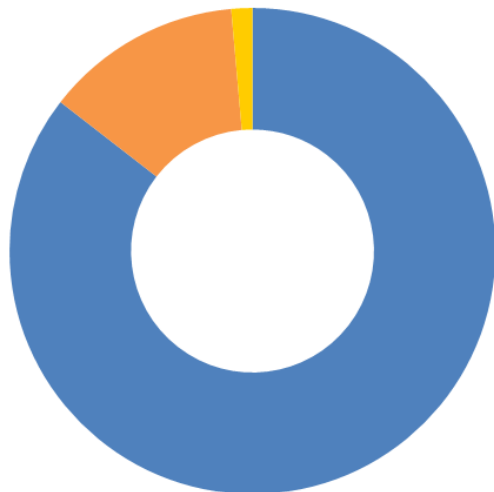

- Grants, Contributions, & Other: \$202,874; 3.5%

Our Funding

Like many human service organizations, most of our funding is provided through contracts for service at the state level. We are proud to work with the Department of Developmental Disabilities and the Department of Children and Families of the Commonwealth of Massachusetts.

We also receive grants from The Bete Family Foundation, The Children's Trust, Community Action Pioneer Valley, Heywood Hospital, and The United Way of Franklin County. Additional grant funding is provided by the Office of Elder Affairs via our partnership with Highland Valley Elder Services and LifePath. The Jean Martin & Bettie Kravetz Funds are managed by the Community Foundation of Western Massachusetts.

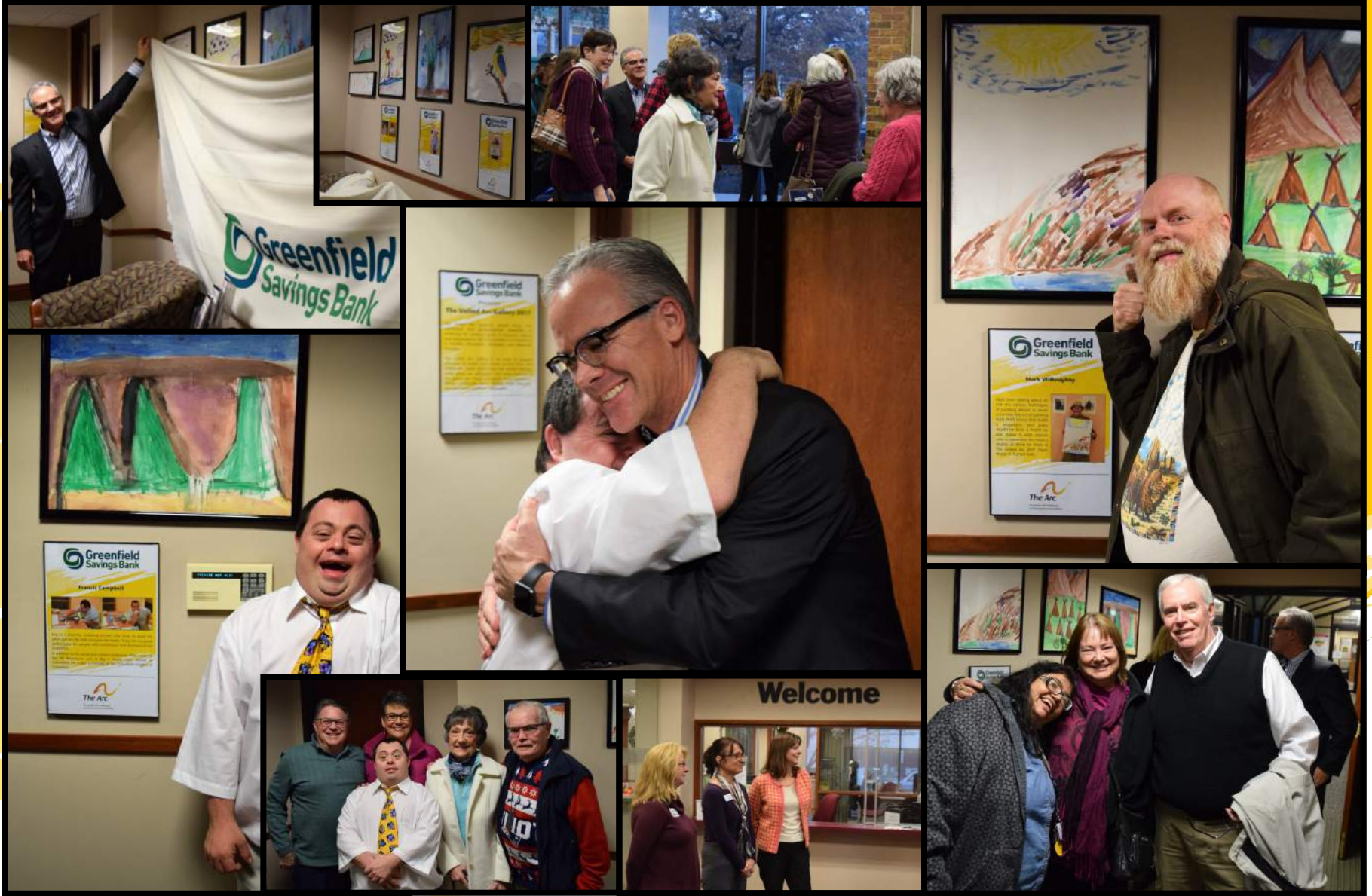
